Customer Feature

Some descriptions in "kodeverk" 7426 have been updated. [RENO-15128, Resolved, As a user, I want to see new names for some kodeverk 7426 codes]

Feature

The help file has been updated for the FM client.

[RENO-15511, Resolved, As a user I want to see an updated version of the FM 4.6 help]

User help file updated to match FM version 4.4.0. New/updated text is in English. [RENO-15386, Resolved, As a user I want to see an updated version of the FM help]

During discharge samstemming, clicking the Add button on the matched RF prescription for an updated resept, a new row (treatment) will be created for the incoming prescription from discharge. The new row will be unmatched and the user is required to handle it before closing samstemming. [RENO-15362, Resolved, As a doctor i want to handle external items when matched with Meona items in discharge samstemming]

In "LIB historikk" an new popup has been added for active stops "X" icon, where the user can left click on the icon to see what users where involved in the stopping.

Customer Defect

Fixed a bug where FM would stop processing incoming asynchronous messages. [RENO-15555 (208636), Resolved, FM fails to read asynchronous messages from the inbox folder]

Fixed database reference error when canceling Discharge samstemming. [RENO-15526, Resolved, Error when canceling Discharge samstemming]

Fixed samstemming changes when the discharge session is initialized or continued by two different doctors.

[RENO-15525 (207724), Resolved, VS: 207724 - Discharge samstemming changes after doctor has closed the samstemming and reopens it again.]

Fixed mandatory yellow frame not showing during discharge samstemming [RENO-15514 (207447), Resolved, VS: 207447 - External LIB items that do not match Meona LIB, do not have yellow frame as the RFC#12 2.4.5.1 indicates that they should have]

Fixed a problem where the FNR of a newly created patient would be marked as inactive, and therefore not shown in FM UI or sent to the RF.

[RENO-15510 (207264), Resolved, VS: 207264 - FM does not show PID when we create new patients]

Fixed FM not accepting a new changed file from Meona.

[RENO-15504 (207061), Resolved, VS: 207061 - FM does not accept a new changed file from Meona when FM already has received one from Meona without opening FM inbetween those two files.]

Items stopped in Meona "samstemming" that are only local, i.e. do not have an RF match, are now correctly shown as handled.

[RENO-15499 (206823), Resolved, Stopping a Meona item in discharge samstemming leaves the item with a "yellow triangle" warning]

The FM will not send out more than one personal identification number per patient. [RENO-15491 (206515), Resolved, RF rejects messages after the patient ID has been updated in FM]

Fixed error when cleaning up Helseld failed client registrations

[RENO-15421, Resolved, Cleaning up Helseld client registrations is not working]

Fixed browser freezing errors when performing Helseld login [RENO-15393, Resolved, No result after PIN code to KJ lookup for Doctor]

Inbox messages about stop suggestions are now deleted when the doctor accepts the suggestion [RENO-15378 (Support 412582), Resolved, Inbox message about stop draft is not deleted when the doctor accepts the draft]

Inbox messages about pending M1 message on the signing queue are now not deleted when the doctor accepts a Reg-i-LIB draft for the patient. Note: a side-effect is that the inbox message may now be recreated after the doctor has marked it as handled. This may happen when closing the FM and there are still old M1 on the signing queue. Previously, it was only created if the M1 was put on the signing queue in the current FM session.

[RENO-15377 (Support 469452), Resolved, Inbox message about unsent resept is deleted when the doctor accepts a Reg draft, when there is a resept on the signing queue]

Magistrelle Prescriptions in the FM allow longer package size units than before to prevent db error when prescribing.

[RENO-15370 (204703), Resolved, Cannot prescribe a preparation when using FEST with updated kodeverk for package size units]

Inbox message about unsent resept is no longer deleted when an assistant undoes a draft, even if there is another resept on the signing queue.

[RENO-15324 (203203), Resolved, Inbox message about unsent resept is deleted when an assistant undoes a draft, even if there is another resept on the signing queue]

M5 is now sent with M25.1 when "Knytt til LIB-oppføring i lokal LIB" from M25.2 keeping the local prescription.

[RENO-15290 (202304), Resolved, VS: 202304 - M5 is not sent with M25.1 when "Knytt til LIB-oppføring i lokal LIB" from M25.2 keeping the local prescription.]

Fixed LIB element in M5 not showing in sent M25.1 under seponated after "Knytt til LIB oppføring" from M25.2 prescription (keeping the local prescription)

[RENO-15289 (202305), Resolved, VS: 202305 - LIB element in M5 does not show in sent M25.1 under seponated after "Knytt til LIB oppføring" keeping the local prescription, from M25.2 is done.]

Users are now able to undo import suggestions when opening a new samstemming session. [RENO-15249 (200900), Resolved, Cannot undo an import suggestion from samstemming]

The FM now tries to use only 9 digit HPRnumbers, i.e. if the numbers are shorter then number will be padded with zeros on the left so it will be 9 digits long.

[RENO-15241 (201123), Resolved, Bug 201123: Looking up IDs with leading zeroes isn't handled correctly]

Samstemming no longer shows "=" between local and external items if a new stop date has been set when importing.

When importing a "kur" with last date in the past, adding a stop date in the future that date will shown on the item.

[RENO-15238 (200798), Resolved, Samstemming shows "=" between local and external items if a new stop date has been set when importing]

Prescriptions actively stopped by user on the same day the treatment starts are sent out in a "multidose" message (M25.1) with a stop date and time of stopping.

[RENO-15177 (197667), Resolved, LIB-ansvarlig sends M1 and M25.1 and seponers the same day then the seponeringsdate is at the beginning of next day]

As there is no time-limit longer on undoing an pending or failed prescription (e-resept) there is no longer any time limit on undoing a pending or failed recall

[RENO-15129, Resolved, Undo of renewal after 24 hours, leaves the M5 on the signing queue]

A new detailed tool tip has been added to the sign / send button if the last lookup for the patient in context was a limited one.

[RENO-14662 (Bug 173421), Resolved, Bug 173421: Patient with Nei to RF lookup in FM 4.1, gets "Siste Begrenset oppslag" when opened in FM 4.2 after new date]

Defect

Fixed a bug where new patients were saved in the db with only FNR or XXX-id if these two ids were the equal.

[RENO-15548, Resolved, New patients are saved in the db with either FNR or XXX-id]

Empty prescriber ("Forskriver") strings should no longer be padded with 9 zeros. [RENO-15436, Resolved, Forskriver is set to be 000000000 in prescriptions that are notInRF]

Fixed update action no longer appearing on matched incoming AK prescriptions [RENO-15432, Resolved, Impossible to update a local AK prescription in samstemming with a newer incoming AK prescription]

Fixed an issue where notification on not included locked prescriptions was shown twice when RF lookup was processed.

[RENO-15431, Resolved, User notified of locked prescriptions in LIB that haven't been added to the LIB]

Notification on not included locked prescriptions was shown twice when RF lookup is processed. This has been fixed.

[RENO-15425, Resolved, Notification on not included locked prescriptions is shown twice when RF lookup is processed]

Fixed an issue where the same local Refnr was shown multiple times in a warning message related to RF lookup

[RENO-15424, Resolved, Same local refnr shown multiple times in a warning message related to RF lookup]

Improved error handling and tracing when performing Helseld logins. [RENO-15420, Resolved, Errors occurring during Helseld login are not properly handled/show]

A few issues were fixed related to the Meona discharge Samstemming (RFC#12). [RENO-15417, Resolved, History items in samstemming are shown differently in new samstemming than in reopened samstemming]

Fixed tool tip warning error when changing lifetime on resepts for fetotoxic drugs to exactly one year. [RENO-15384, Resolved, Changing lifetime on resepts for fetotoxic drugs is not how it should be.]

FM no longer interprets stop date from AK prescriptions when there's a locally active AK journal [RENO-15194, Resolved, FM interprets "Sluttidspunkt" in AK prescription as a "Seponeringsdato"]

After importing in "samstemming" a message (M97) requesting delivery information is sent out for imported prescriptions, just like when importing from AF. [RENO-15188, Resolved, M9.7 isn't sent after importing a resept from samstemming]
